I. SUMMARY OF CHANGES: Claims for the States of Arizona, Montana, North Dakota, South Dakota, Utah, and Wyoming will be processed by Noridian Administrative Services using new contractor numbers. Under the new MAC contractor numbering structure, the contractor number is considered a 5 position numeric, while the Business Segment Indicator (BSI) is considered a 3 position alpha field. The contractor workload identifier is defined as a combination of the 5 position contractor number and the 3 position BSI. If you do not currently use the BSI, you do not need to implement it based on this CR.

SUBJECT: New Contractor Numbers for Jurisdiction 3 Part AB Medicare Administrative Services (MAC) Workload.

I. GENERAL INFORMATION

- A. Background:** The purpose of this change request is to notify all interested parties that The Centers for Medicare and Medicaid Services (CMS) has assigned new contractor numbers to the states in the AB Medicare Administrative Contractor (MAC) Jurisdiction 3. Claims for the states of Arizona, Montana, North Dakota, South Dakota, Utah, and Wyoming will be processed by Noridian Administrative Services using the contractor numbers and effective dates listed below. Note that Mutual of Omaha Medicare providers will continue to do business with Mutual of Omaha.

The contractor workload identifier is defined as a combination of the 5 position contractor number and the 3 position BSI(Business Segment Indicator). If you do not currently use the BSI, you do not need to implement it based on this CR. In other words, for those applications that currently use and/or recognize 8 positions for identifying the contractor (5 position contractor number plus the 3 position BSI) all 8 positions must be utilized. Conversely, for those applications that only recognize and/or use the 5 position contractor number, the BSI will not need to be used. For jurisdiction reporting, the “roll-up” jurisdiction ID will be 03001 for Part A and 03002 for Part B.
